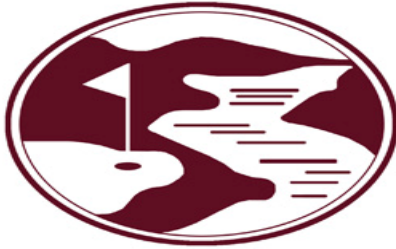

TOURNAMENT COST: River's Bend Golf Club will host the following golf tournament at its golf facility based on the following terms and conditions, and the Organization agrees to pay to River's Bend Golf Club at the following fees:

- (A) *The Minimum Number of Players* (referred to as the "Guaranteed Contract Minimum"); and
- (B) *Final Guaranteed Number of players that Participate* in the tournament.

NUMBER OF PLAYERS: River's Bend Golf Club must be notified of the final guaranteed number of participants (7) business days prior to the Tournament Date. **If either number is greater than the Minimum Number set forth in the contract, then the greater number shall constitute the Minimum Number guaranteed and will be charged accordingly.**

TOURNAMENT PARTICIPATION: The Tournament Fee includes greens fees and golf cart fee for 18 holes in the specified format of play. In addition, River's Bend Golf Club will provide cart staging and course set up. The Club must be supplied with a list of players, pairings, handicaps when necessary, and all contest information at least 5 days prior to the tournament date for proper tournament coordination.

FOOD AND BEVERAGE: Food and beverage shall be provided for each Participant and each Non- Golfer as indicated in attachment (A). All food and beverage must be purchased through River's Bend Golf Club. The Club must be notified of the final Guaranteed Number for food and beverages at least (7) business days prior to the Tournament Date. Food and beverages will be charged according to the Final Guaranteed Number or Actual Number on the day of the event, **whichever number is greater of the two. An 18% gratuity and 5 % Sales Tax will be added to the Food and Beverage total at the completion of the event.**

RULES AND REGULATIONS: Each Participant is expected to follow all rules in effect on the Date of the Tournament as set forth by the Head Professional and the Club Superintendent. Participants are required to wear proper golf attire including a collared shirt, pants, or Bermuda length shorts. Blue jeans are strictly prohibited, along with jean shorts, cut-offs, tank tops and any other cleats then golf cleats. Tennis shoes are permitted. River's Bend is a Soft Spike facility (no metal cleats). Pace of play is strongly enforced. These rules will be clearly stated into a Rules Format Sheet that may



or may not be provided to each contestant, but will be posted in the club house. River's Bend Golf Club will strictly enforce these rules. Any damage that occurs during the course of play shall be the financial responsibility of the person(s) who cause such damage and the Organization. Players are responsible for all homeowner property damage.

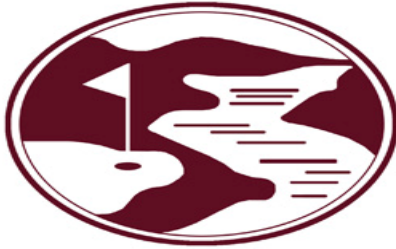
TAX EXEMPT ORGANIZATIONS: If the organization is tax-exempt, a copy of the tax-exempt certificate must be provided to River's Bend Golf Club at the time the Contract is signed. In the event that the State Comptroller or other controlling governmental authority determines that this function does not qualify for an exemption the Organization is not tax-exempt, the Organization shall be responsible to pay all applicable taxes and shall hold River's Bend Golf Club harmless for such taxes or other costs regarding same. River's Bend Golf Club reserves the right in its sole and absolute discretion, to determine that the documentation provided by the Organization is insufficient to deem the Organization as tax-exempt.

PAYMENT: Payment shall be as follows

DEPOSIT: A deposit of **\$200.00** is due at the time a signed original Contract is submitted to River's Bend Golf Club within ten (10) days from the date of the signature by River's Bend Golf Club; this Contract shall be deemed null and void and of no further force or effect. The Organization understands that upon payment of the Deposit of the Tournament Date is reserved for the Tournament and the Deposits are NON-Refundable.

BALANCE DUE: The balance due under this Contract shall be due as follows:

- (i) **The balance of the Guaranteed Contract Minimum shall be due at least three business days before the Tournament Date; and**
- (ii) **At the conclusion of the Tournament, a Final Bill shall be presented to the Organization reflecting all fees incurred for the Tournament including any charges in excess of the Guaranteed Contract Minimum. Payment of any balances shall be due upon presentation of the Final Bill.**

Other than the deposit, all payments must be by certified checks, cash, bank money order, or credit card (all major credit cards accepted). Please note that it is your responsibility to contact River's Bend Golf Club's accounting office to clarify any questions concerning the bill **prior to the due date**. In the event any payment as set forth above is late, interest shall accrue at the rate of 18% per annum and in the event that this matter is turned over to an attorney, you will be responsible for reasonable attorney's fees and other costs of collection.

WEATHER CANCELLATION POLICY: The Organizations acknowledges that a Tournament will NOT be automatically cancelled due to rain or other inclement weather. An event will be cancelled only if River's Bend Golf Club determines, in its sole and absolute discretion that the player's safety is in jeopardy or potential damage to the course may occur. A cancelled Tournament shall be rescheduled at a time and date mutually accepted by the Organization and River's Bend Golf Club unless in River's Bend Golf Club's sole and absolute discretion; it can not be rescheduled due to prior commitments for the Golf Course and / or weather.

Should the Organization cancel a Tournament within five (5) business days of the day of the event, the Organization shall be responsible for payment of irretrievable costs such as food and other perishable items, which will be charged at wholesale cost (Irretrievable Costs"). Such charge shall be in addition to the other fees set forth in this Contract. In the event that the tournament is not rescheduled, then all monies paid by the Organization shall be refunded minus the Irretrievable Costs and the deposit. The expense of items supplied by outside vendors shall be the sole responsibility of the Organization.

The undersigned represents that he/she has fully read and understands the terms of this Contract and that he/she is dually authorized to enter into this Contract on behalf of the Organization. By signing this Contract you hereby unconditionally and irrevocably guarantee the payment and performance of the Organization's obligations as set forth in the Contract.
